I am dismayed to hear, through the admission in your email to Superintendent Angeli, that you had a conversation with him, directly in person, at a recent Board committee hearing, apparently about some of the issues involved in the ongoing litigation brought forth by your filing of the §10-4b complaint against the District.

As you well know, the Superintendent is represented by counsel in this litigation, and because the litigation is ongoing, neither you nor your clients should be having any discussions with any of my clients about the issues involved in that complaint. Any such concerns or questions that you, or your clients have, should be directed through you to me as counsel for the District.

As an attorney, you should be well aware of these ethical rules, and I am appalled that you have not adhered to them. Please cease and desist all such communication immediately. If you need to convey any information regarding this matter, you may do so only through me as counsel for the District.

Because apparently you were directed by Superintendent Angeli to pose your request directly to me for certain documents discussed at a recent Board committee meeting, and because you now have done so, I am attaching those documents to this email per your request. Again, all other future communications should be presented directly to me.
